

**OFFICE OF THE DISTRICT AND SESSIONS JUDGE:: DHEMAJI**

**Minutes of meeting of Information and Communication Technology (ICT) Committee, held on 04-05-2017.**

A meeting of the ICT Committee is held today under the chairmanship of Hon'ble District & sessions Judge, Dhemaji at 3.30 pm in the office and chamber of Hon'ble District & Sessions Judge. The following resolutions have been taken in the meeting.

**Item No 1:** Regarding undated cases and Judgment uploading in the CIS (Case Information System).

**Resolution No. 1:** Systems Officer has informed the ICT committee that the the Bench Assistants update the court proceeding on daily basis so as to enable zero undated cases in the CIS of the District Judiciary, Dhemaji. In emergency, Systems Officer help in updating the daily court proceedings in the CIS. The Stenographers and the Bench Assistants of the respective court upload the the Judgments and Orders in the Case Information System regularly, with certain exception of one or two cases sometimes but, the same has also been being looked into and updated immediately.

**Item No 2:** Regarding VPNoBB connection at Dhemaji and Jonai.

**Resolution No. 2:** The Systems Officer has informed the ICT committee that he has communicated the BSNL authority, Dhemaji and Jonai to provide the VPNoBB connection at Dhemaji and Jonai. Accordingly, the BSNL officials of Dhemaji visited the court on 4-5-2017 and worked for the day to establish the connection which is under process.

**Item No 3:** Regarding Broadband connection at District Jail, Dhemaji.

**Resolution No. 3:** The Systems Officer has informed the ICT committee that he has communicated the BSNL authority, Dhemaji. The Systems Officer is directed to remind the concerned authority.

**Item No 4:** Regarding Quotations of new Printer and Scanner at Dhemaji District Judiciary.

**Resolution No. 4:** The Systems Officer has informed the ICT committee that no Sealed quotations are received from any firm for Supply of Printers & Scanners at District Judiciary, Dhemaji which was sought for vide Memo No. DJDH/851-54/2017, dated Dhemaji the 1<sup>st</sup> April/2017. However, a quotation was received on 3-5-2017 after expiry of quotation period on 2-5-2017. So, the received quotation has not been opened and is accordingly rejected. The committee also observed that e-courts project phase-II will supply 16 numbers of

printers which was sought for vide Memo HC.XLV-183/2015/935/PM&P dated 27.04.2017. Therefore, the fresh advertisement calling for quotation be called for only after clarification from Hon'ble Gauhati High Court.
